DANCE PENALTY INFORMATION/DEDUCTION EXPLANATIONS:

TIMING REQUIREMENTS: (ALL CATEGORIES): .5 Deduction (1/2 pt.) will be deducted for each second over the time limit. In Game Day Dance this will be deducted per section as well as for total routine time when over the time limits. If under 1:30 in Jazz/Pom/Hip Hop then a total of 1 point will be deducted total and not per second under.

OTHER:

Delay of Competition: 1 Pt. will be deducted if a team is not in the ready line and ready to perform on time or cannot be found and able to perform within 5 minutes of their scheduled performance time. (Exceptions: Illness or Injury).

Music Issues/Compliance: 2 Pts. will be deducted if unable to provide proof of compliant music if questioned or challenged.

PERFORMANCE INFRACTIONS:

Uniforms: 1 Pt. will be deducted per team for all inappropriate uniforms and/or prohibited footwear and/or unsafe jewelry. If spotted before performance, coaches may be asked to have dancers remove all unsafe items.

Stunts/Lifts/Drops/Etc: 2 Pts. per occurrence will be deducted per safety violation per dancer performing prohibited skill.

Category Elements: 1 Pt. will be deducted for the following: Inappropriate Music and/or choreography (per occurrence).
